My term as the President of Vedic Center of Greenville executive committee is nearing an end. I presented my vision at the start of my term in 2007, and supplemented it with specific goals at start of this year. Even with the time and resource constraints, we were able to accomplish many of these goals and make significant progress in many others.

I am especially very happy with our progress in further uniting our community, providing transparency in our accounts and funding, and hosting more religious and cultural events. If you have not yet pledged your financial support, please do so to help us quickly reduce this debt.

We'll have a very busy schedule for the remainder of this year, starting soon with Navratri, followed by a joint Diwali program with IAGG, and ending with the New Year Annakut to celebrate start of Vikram Samvat 2065.
